1. Information about members of The Supervisory Board:

The Annual General Meeting of Shareholders of 2017 dated April 24th, 2018 approved the new governance model according to the best practice, officially no longer the Supervisory Board and established the Internal Audit Board under the BOD. Besides, the Annual General Meeting of Shareholders 2018 on April 23rd, 2019 approved the resolution regarding establishing the Audit Subcommittee under the BOD to support and advise for the BOD in corporate governance activities. This new model will be a condition for TTC Land to develop sustainably and ensure the optimal benefits of investors.

2. Supervision activities of the Audit Subcommittee for the BOD, BOM and shareholders:

- The Audit Subcommittee is under the BOD to support the BOD in Corporate Governance, in charge of supervisory function all activities of the company. The Audit Subcommittee has the same function with the Internal Audit mentioned in point B, clause 1, article 134 of the Enterprise Law.
- Establishing the Construction Inspection Board (CIB) from the former construction inspection team, responsible for double checking construction field, enhancing the role of inspection, supervision of projects and buildings.
- The Audit Subcommittee deployed 40 examinations, gaining 160% of the plan (16 examinations about compliance; 02 examinations about financial statements; 22 examinations about construction investment and on-site visit);
- Inspecting, reviewing payment records from May 2019, the CIB examined approximately 40 projects' payments; reviewing directly real quantity, quality at the onsite projects to detect mistakes from the beginning, thereby asking involved departments/ personals finding the solution to fix/ correct records before submitting to the BOD for consideration and approval;
- Along with the restructure of the organizational chart, the incisive directions from the BOD has initially brought positive results for TTC Land. The supervision is transparent, joining in the early period of deployment in all fields to forecast and control risks. Besides, based on TTC Land orientation and overall goals, the CIB also proposed disciplined methods for various cases that are not compliant to keep internal regulations in line.
